SERVICES INCLUDE COMPREHENSIVE COORDINATED TREATMENT OF CHRONIC DISEASES LIKE HYPERTENSION, DIABETES, ASTHMA, AND HIGH CHOLESTEROL, PLUS SPECIALTY CLINICS IN PHYSICAL THERAPY, DERMATOLOGY, NEUROLOGY, OPHTHALMOLOGY, AND RHEUMATOLOGY. NEW FOR 2015 WAS THE ADDITION OF PEDIATRIC SERVICES, INCLUDING WELL CHILD VISITS AND IMMUNIZATION ACCESS. WE CONTINUE TO OFFER FAMILY PLANNING SERVICES TO ADOLESCENTS. THE MEDICAL DEPARTMENT IS ALSO APPLYING FOR MEDICAL HOME RECOGNITION FROM THE NATIONAL COMMITTEE FOR QUALITY ASSURANCE (NCQA) IN 2016.

THE FREE CLINIC'S BEHAVIORAL HEALTH PROGRAM PROVIDES PSYCHIATRIC AND PSYCHOLOGICAL INDIVIDUAL COUNSELING SERVICES (4,374 ENCOUNTERS, 480 PATIENTS) TO ADULTS, MOST OF WHOM LACK INSURANCE FOR TREATMENT OF MENTAL HEALTH PROBLEMS. THERE ARE ALSO ISSUE-ORIENTED COUNSELING SERVICES AVAILABLE FOR DEPRESSION. A SEPARATE SUBSTANCE ABUSE PROGRAM (3,606 ENCOUNTERS, 287 PATIENTS) PROVIDES INTENSIVE OUTPATIENT TREATMENT, WHICH INCLUDES BOTH GROUP SERVICES AND INDIVIDUAL COUNSELING. NEW FOR 2015 IS AN INTEGRATED CASE MANAGEMENT PROGRAM THAT ASSISTS PATIENTS WITH ACCESSING EXTERNAL REFERRALS FOR MEDICAL AND SOCIAL HEALTH NEEDS LIKE HOUSING, FOOD, AND TRANSPORTATION.
